SEVEN OF THESE YOUTH HAVE CONTINUED AS ARTISANS AND ARE PRODUCING HIGHER QUALITY, MORE MARKETABLE CROCHET ITEMS THAN HAD BEEN THE CASE BEFORE INTERVENTION FROM THE AAC. OF THE 14 OTHERS WHO WERE FOLLOWED UP, ALL BUT TWO ARE INVOLVED IN A DEFINITE CAREER PATH AND EITHER WORKING OR ON THE WAY TO PARTICIPATION IN THE LABOR MARKET. TWO OF THESE 14 DO REQUIRE ADDITIONAL COUNSELING TO HELP THEM FIND A SATISFACTORY CAREER PATH.
